## MEMBER DEFINITION IN BYLAWS:

A cementitious material company member is an entity directly engaged in either manufacturing, distributing or selling Portland cement or blended cement, and companies distributing or selling supplementary cementitious materials, such as fly ash, slag, or others.

Eligible companies include those that supply cementitious or other binder products for use in the following paving segments/products in public markets (federal, state, county, local, and toll), private markets and public-private partnerships:

- Airport, Highway & Street-Road Paving/Overlays
- Parking Lot & Industrial Paving/Overlays
- Concrete Pavement Repair/Preservation
- Roller-Compacted Concrete Paving
- Concrete & RCC Shoulders
- Cement treated base/soil cement stabilization

## ACPA MEMBERSHIP IS TAX DEDUCTIBLE:

The American Concrete Pavement Association (ACPA) is a 501(c)6 organization. For federal tax purposes, contributions to the ACPA are a deductible business expense. **For 2022, 0.23% of membership dues is classified as lobbying activities and is not tax deductible per IRS regulations.** For 2022, no portion of ACPA dues are contributed to political campaigns or candidates.

## RESEARCH CONTRIBUTION:

ACPA maintains a commitment to research and education on behalf of the industry. A voluntary member contribution designated for the Innovative Pavement Research Foundation (IPRF), a 501(c)3 organization operated by ACPA will be restricted for use in funding research and education priorities. The IPRF applies its funds toward projects that meet the strategic intent of the concrete pavement industry, such as:

- **Performance-Engineered Concrete Mixtures** – an effort shared by the ACPA/IPRF and its partner, National Concrete Pavement Technology Center to develop new mixture design procedures for concrete paving mixtures. Performance-engineered mixtures will better ensure concrete pavement applications will meet and/or exceed the intended design life without premature materials-related durability problems.
  - **Concrete Overlays** – an effort shared by the ACPA/IPRF and its partner, National Concrete Pavement Technology Center to refine and implement improved guidance on concrete overlays for existing concrete or asphalt pavements.
  - **Technology Transfer and Education** – an effort directed toward the development knowledgeable engineers about concrete pavement and the concrete pavement industry.

**ANNUAL DUES:**

Domestic manufacturers, distributors or brokers ..... \$ 5,000 Annual Dues (plus per ton assessment)  
Suppliers of Fly Ash, Slag and Other Cementitious Materials..... \$ 5,750 Annual Dues  
International Cementitious Material Suppliers ..... \$ 5,000 Annual Dues (\$2,800 if company also belongs domestically)

**ASSESSMENTS:**

Assessments are based on contract-direct cement tonnage within the U.S. from assessable work, as follows:

National Rate: \$0.45 per ton (for up to first 200,000 tons)  
\$0.35 per ton (for tons over 200,000 tons)

1. The assessment is to be determined and implemented in arrears. For 2022, assessments are to be calculated on the tons shipped during the period from July 1st, 2020 through June 30, 2021.
  2. Contracted tonnage reports are based on tons shipped in the reporting period.
  3. Applicable tonnage is:
    - a. Portland cement or blended cement tonnage involved in work that is directly contracted between cement companies and contractors, regardless of whether the work was contracted with a general or subcontractor, or whether it was a current member or non-member of ACPA.
    - b. Used in contracts involving the products and markets listed above.
  4. Contracted tonnage reports will be made to a third-party accounting firm as directed on reporting forms, including volumes by state.
  5. Total payments are capped at \$50,000 for companies with a U.S. cement clinker production capacity of 2 million tons or less and \$300,000 for companies with more than 2 million tons of clinker capacity.
  6. Payments may be on a quarterly or annual basis at the option of the member company.
