**ACPA MEMBERSHIP IS TAX DEDUCTIBLE:**

The American Concrete Pavement Association (ACPA) is a 501(c)6 organization. For federal tax purposes, contributions to the ACPA are a deductible business expense. **For 2022, 0.23% of membership dues is classified as lobbying activities and is not tax deductible per IRS regulations.** For 2022, no portion of ACPA dues are contributed to political campaigns or candidates.

**PLEASE NOTE OUR COMMITMENT TO RESEARCH:**

ACPA maintains a commitment to research and education on behalf of the industry. A voluntary member contribution designated for the Innovative Pavement Research Foundation (IPRF), a 501(c)3 organization operated by ACPA will be restricted for use in funding research and education priorities. The IPRF applies its funds toward projects that meet the strategic intent of the concrete pavement industry, such as:

- **Performance-Engineered Concrete Mixtures** – an effort shared by the ACPA/IPRF and its partner, National Concrete Pavement Technology Center to develop new mixture design procedures for concrete paving mixtures. Performance-engineered mixtures will better ensure concrete pavement applications will meet and/or exceed the intended design life without premature materials-related durability problems.
- **Concrete Overlays** – an effort shared by the ACPA/IPRF and its partner, National Concrete Pavement Technology Center to refine and implement improved guidance on concrete overlays for existing concrete or asphalt pavements.
- **Technology Transfer and Education** – an effort directed toward the development knowledgeable engineers about concrete pavement and the concrete pavement industry.

1. All contractors that join an affiliated local paving promotion organization (Chapter or State Association) that is affiliated with ACPA automatically become members of ACPA, regardless of size or volume of work.
2. Any contractor from an area that does not have an ACPA-affiliated chapter or state association joins ACPA National directly and receives benefits from ACPA National.
3. Contractor members are obligated to pay local and national assessment dues in affiliated areas that they perform work and national assessments in unaffiliated local areas that they perform work.
4. The assessment rates, collection timing and other requirements of each affiliated chapter/state associations apply to the work within its territories performed by any contractor member, regardless of their designated "home" chapter/state association.
5. Assessment rates, assessable items and other requirements vary by affiliated chapter/state association and apply to the work within its territories performed by any contractor member. All assessment rates are published on the ACPA's members-only web page at [www.acpa.org](http://www.acpa.org).
6. Once established, all contractor memberships are considered active unless a letter of resignation of membership is received in writing at the Association headquarters office.

**DUES RATES:**

ACPA national assessments are directly proportional to the volume of applicable work awarded to your company. Assessments are a reflection of the value of the research, policy and standards creation/monitoring, promotion and other Association efforts that create the opportunities for projects, as well as the technical service that may be required on a project. Assessments are only applied to the type of work that the Association promotes, including highway, airport, street, road, industrial concrete paving and repair. Specialty concrete paving, such as roller-compacted and pervious concrete are also included.

National Rate: \$0.55/\$1000 of assessable work (paving items only!)

**Note:** Domestic contractor members from areas that do not have a local affiliated chapter or state association will receive volume assessment forms for projects identified from state or U.S. territory bid tabulations, as well as self-assessment forms. Domestic national-direct contractor members are asked to complete the forms and return them to the ACPA national office. ACPA will provide a dues invoice for appropriate financial record-keeping by the member based on their information. Where letting records are available, ACPA will provide specific assessment invoicing using those records.
